I acknowledge that I am voluntarily choosing for my student to travel to and/or from each Athletic Activity by private vehicle with me or by himself/herself, separately from the transportation services provided by the school. I understand and accept that Community High School District 155 ("District") does not endorse or sponsor private vehicle transportation to and/or from the Athletic Activity and assumes no liability for the private vehicle transport. I further understand that no employee or representative of the District will accompany my student during his/her transportation to and/or from the Athletic Activity. I knowingly and voluntarily assume all risks associated with my student's transportation to and/or from the Athletic Activity, including the risks of any injury, accident, illness, allergic reaction, damage or loss to person or property, or other harm arising out of, related to, or connected with this transportation.

I acknowledge that when a private vehicle is used for transporting my student to and/or from the Athletic Activity, the private vehicle operator or registered owner is responsible for carrying their own vehicle insurance with liability. I further acknowledge and accept that the District has no authority to confirm and/or endorse any private vehicle operator or registered owner's insurance status and will not do so. I also acknowledge that when a private vehicle is used to transport my student to and/or from the Athletic Activity, in case of an accident, injury or otherwise, the District's insurance coverage does not extend to my student.

I understand that although I must complete and return this form only once this semester, either I or my student will provide written notification to the head coach of the Athletic Activity at least 24 hours prior to the start of the Athletic Activity.

RELEASE FROM LIABILITY

By signing this form, to the fullest extent permitted by the law, I hereby fully and unconditionally release, waive, indemnify, and hold harmless the Board of Education of Community High School District 155, as well as its individual Board members, employees, agents, attorneys, representatives, volunteers, and successors, from any and all liability, including but not limited to, actions, causes of action, any and all damages, debts, claims, obligations, personal injuries, including death, disabilities, medical expenses, attorney's fees and court costs, or other demands of any kind and nature whatsoever which may arise out of, relate to, or in connection with the transportation of my student to and/or from the Athletic Activity. The terms of this liability waiver shall also serve as a release for my heirs, estate, executors, administrators, assignees and agents.

I have carefully read this Consent and Liability Waiver Form, fully understand its terms, and execute it voluntarily. I know that by signing this document, I waive my right to sue and agree to hold harmless the Board of Education of Community High School District 155, and its individual Board members, employees, agents, attorneys, representatives, volunteers, and successors.
