## 4. Committee Reports

- Concessions

  - We might also look into heated/insulated bags to keep food warm.
- Spirit Wear
  - o Football really helped, and we have been selling a lot of inventory
  - o The only issue is people ordering online and not picking up their spirit wear. Then sometimes they are disputing. Would like to see if we can make a cell number a

- required field in PayPal and potentially require people to acknowledge that orders need to be picked up at the athletic office. Marcia said she believed we could capture cell numbers in PayPal so that Stacy can txt people when their orders are ready.
