U.S. Extemporaneous Speaking —(7 minute maximum) After drawing three questions concerning foreign or domestic affairs, the contestant will choose one and prepare a speech. During the allotted thirty minutes of preparation time, the contestant may not consult with others. Contestants are expected to speak without the use of notes. Original Oratory —(10 minute maximum) The contestant will present an original persuasive speech from memory. The speech may not contain more than 150 words of quoted material. Public Forum —(4-3-4-3-2-3-2 time limits) Two-person teams will debate the MSHSAA-mandated topic: Resolved: The benefits of the United States federal government's use of offensive cyber operations outweigh the harms. Teams will flip each round. The winner of the coin toss can choose either side (pro or con) OR the speaker position (first or last). The coin toss loser has the other choice. Each side is allowed two minutes of preparation during the round. The top eight teams will advance to quarterfinals. Our ballots include ranks. We will be following the MSHSAA time limits, not the NSDA time limits. <i>Many of your judges will be members of the Clayton School District community. Many of the judges will be judging for the first time. We advise you to keep this in mind and adjust your performances accordingly.</i>
