Not only will you earn the immediate rewards of medals or trophies, but you also will earn the long lasting rewards of confidence, public-speaking ability, friendship, poise, high self-esteem, and the list could go on.

Prescott High School is an active member in the Wisconsin High School Forensics Association (WHSFA). The PHS forensics program has become a competitive team in District 3: winning team trophies regularly. The PHS forensics team has also been recognized as one of the top programs in the state of Wisconsin: winning the prestigious Excellence in Speech Award in 2009, 2011, 2012, 2014, and 2016.



# FORENSICS CATEGORIES 2017-2018

You write your own speech:

**Demonstration:** The speaker should explain how to do something or how something works; the speech must be instructive and present valuable and significant information. There may be one or TWO speakers.

Maximum time limit: 10 minutes including setup and strike down

**Four-Minute:** The challenge of the speaker is to present well-developed material that has the primary intent of informing, although persuasive elements may be used.

Maximum time limit: 4 minutes

**Moments in History:** The speech focuses on exploring a particular part of history.

This year's topics: 1801-1840 and/or 1930s.

Maximum time limit: 6 minutes

**Oratory:** A persuasive speech that persuades the audience on a significant topic.

Maximum time limit: 10 minutes

**Public Address:** Presenting a speech that is directly responsive to a contemporary issue.

This year's topics:

- 1. How involved should parents be in their child's education?
- 2. To what extent, if any, does immigration affect employment?
- 3. What, if anything, can be done to eliminate food deserts in America?
- 4. To what extent, if any, are prisons in the US effective?
- 5. To what degree, if any, should space exploration continue?

Maximum time limit: 8 minutes

**Special Occasion:** A presentation that deals with a particular occasion.

This year's topics:

- 1. A resignation speech
- 2. A hall of fame induction speech
- 3. A pep talk from a coach
- 4. A tribute to the life of an ancestor, either living or deceased

Maximum time limit: 6 minutes.

#### *Limited Prep Time:*

**Extemporaneous:** The speech should provide a direct response to the question drawn. The challenge is to phrase a clear proposition and support it with evidence and reasoning.

Maximum time limit: 7 minutes

**Radio News Reporting:** The speaker puts together a well-organized newscast in a short amount of time.

Maximum time limit: 5 minutes

**Impromptu:** Speaker puts together a spontaneous response to a specific prompt in a limited time frame.

Maximum time limit: 5 minutes (to prepare and speak)

Interpretation Categories—Find your material in literature--Not memorized:

**Poetry:** A presentation of a poem or a group of poems centering on a specific theme or emotion.

Maximum time limit: 8 minutes

**Prose:** A presentation from prose literature (short stories, novels, essay, etc) centering on a specific theme or emotion.

Maximum time limit: 8 minutes

**Farrago:** Speech put together from a variety of literary genres that all address a central, specific theme or emotion.

Maximum time limit: 10 minutes.

**Group Interpretive Reading:** Presenting a literary script through oral reading and symbolic characterization rather than acting. Presented by 2-5 readers.

Maximum time limit: 12 minutes.

Interpretation Category—Multiple Pieces—Memorized:

**Storytelling:** Presenting a story in an imaginative and interesting way.

This year's topics:

- 1. A story about outer space.
- 2. A story from an indigenous culture.
- 3. A story about something that is lost and/or found.
- 4. A nautical story.

Maximum time limit: 8 minutes.

Acting Category—Find your material in literature—Memorized:

**Play-Acting:** An entry in this category is a presentation of a scene or cutting from a play by a group of 2-5 participants. Memorized.

Maximum time limit: 12 minutes

**Solo Acting:** Presentation of a cutting from serious or humorous drama. Memorized.

Maximum time limit: 10 minutes

#### **PARTICIPATION**

Any Prescott High School student who enjoys performing and would like to improve his/her public speaking ability is welcome to participate. It is important to become involved in activities at school; therefore, we make every attempt to work around schedules so students can participate in other activities as well as forensics.

#### **ELIGIBILITY**

In order to participate in this activity, students need to be in good academic standing and adhere to the Prescott Activity Code. #### **FEES**

Competing at tournaments is expensive. The school pays an entry fee for each contestant in each tournament, roughly \$5 per person. In addition, we supply one judge per 6 entries and pay \$75 for that judge. Finally, transportation to and from the tournament site is expensive. **To help offset these costs, participants will have to pay the \$110 activity fee. This must be paid before the first tournament.** 

\*\*\*No-shows will be responsible for reimbursing the school for any wasted entry fees.

#### **MATERIALS**

Students are responsible for finding and/or writing their own speeches. The coaches do have a number of resources available, but students participating in forensics are encouraged to explore the library and bookstores for possible selections.

### **VARSITY/JUNIOR VARSITY TEAMS**

A full team consists of 25 entries (group interpretation and play acting may have as many as 5 people, but count as only 1 entry). We can enter a combined total of 12 people for prose, poetry, and farrago; a combined total of 4 groups between play acting and group interpretation; and all other categories are limited to 4 entries. This is the limit for sub district, district, and state. These 25 entries will be the Varsity team. Any entries beyond these 25 will be the junior varsity team.

#### **PARTICIPATION IN TOURNAMENTS**

It is expected that all forensics team members will compete in all tournaments unless prior notification is given to Ms. Sponholz a minimum of **two** weeks in advance.

A forensics participant is a member of a team, just as a basketball player is a member of a team. If one person misses a tournament, the whole team suffers. While the tournaments award individual trophies, they also award team trophies, and EVERY entry counts!

#### PRACTICE POLICY

Starting on December 4, students are expected to practice once a week with one of the coaches. Practice sessions in the early stages of the season will last longer for obvious reasons: speeches need to be researched and written, selections need to be found and cut, and actors need blocking and directing. Once these things are taken care of and the season is underway, the practice sessions are shorter. You will pick the day of the week that works best for your schedule. This will be the same day every week.

Keep in mind that while you do practice with the coaches every week, no amount of "official" practice will help you unless you plan to practice on your own.

#### **DEPARTURE TIMES**

Please BE ON TIME. If we arrive late, we put radio speakers and extemporaneous speakers at a major disadvantage. If you are not on the bus at the required time, we will leave without you, and your parents are responsible for getting you to the tournament.

#### **DRESS CODE**

Dress for SUCCESS! While dress is not part of the critique sheets, it can affect your performance. Appearance is a big part of nonverbal communication, and it is the first thing judges will see. All students should dress up and look their best for competition. **Professional appearance** is what we are striving for. Men should plan on wearing dress pants, button-down shirts, and a tie. Women should seriously consider investing in a blazer. Please don't wear skirts that are really short and shirts that are too revealing.

Absolutely no sweatshirts, T-shirts, tennis shoes, jeans, or Prescott apparel.

## **TOURNAMENT CODE OF CONDUCT**

Any time that you attend a tournament, you are not only representing yourself, but you are also representing your team, your school, and your hometown. We, the coaches, are entrusting you with the good name of PHS Forensics.

#### **CAPTAINS' RESPONSIBILITIES**

Every year, the coaches select two or three Senior team members who have proven themselves to be excellent forensics students and leaders. The captains will fulfill the following duties:

- 1. Be a leader and role model for the team.
- 2. Be a cheerleader and motivator for the team.
- 3. Hand out materials and codes at tournaments.
- 4. Help younger students read and understand the schematic so they know where to go.
- 5. Help coaches prepare for the home tournament.
- 6. Create locker posters for the students competing in the subdistrict, district, and state level competitions.
- 7. Organize the team T-shirt.
- 8. Present highlights of the season at the end-of-the-year banquet.
- 9. Hold Captains' practices when the coaches are unavailable.

#### **AWARDS**

Members of the forensics team are recognized each April. Each participant will receive a Certificate of Participation from the WHSFA. In addition, each participant will be eligible for other awards including: a Forensics letter, Most Valuable Forensicator, Most Improved Forensicator, and others as designated by the team captains.

### LETTERING CRITERIA

The coaches at PHS take pride in the students who participate in forensics and represent our school. We try to recognize and honor all students in this activity through several ways. For those students who exceed the normal expectations of this activity, we offer a special letter.

In order for a forensics participant to letter, he/she must earn at least 10 points. These points may accumulate from year to year.

### Students earn points by:

Attending forensics tournaments 1 point each

Placing at a tournament 2 points for 1st and 2nd place

1 point for 3<sup>rd</sup>, 4<sup>th</sup>, or 5<sup>th</sup> place

Sub district level 1 point for moving on to District

District level 2 points for moving on to State

Placing at State tournament 3 points for Critic's Choice 25

2 points for All State 23-24 1 point for Finalist 20-22

Presenting at the 4N6 Showcase 1 point

Presenting at Kiwanis, school board, etc. 1 point

Students lose points by:

Missing practice (required weekly) 1 point each week

Missing a tournament 1 point

Misplacing materials/poor behavior 1 point per occurrence

No exceptions will be made in the above criteria. In the case of a medical emergency, students will not be deducted points if their parents contact the coach within 24 hours of the event.

Once a student earns the letter, they may continue to accrue points and will be awarded pins for each additional ten points earned. An especially skilled student may earn four pins in a four-year high school forensics career. The tiers shall be: forensics letter winner, achievement in forensics, exceptional achievement in forensics, and elite speech honors.

Forensics participants must uphold the activity code, exhibit good citizenship, and promote a positive team attitude.
