Participating in athletics is a privilege, not a right. With this in mind, the Boys' Golf Staff has established the following contract so that players and parents will understand what is expected of each of them during the season.

EXPECTATIONS

ACADEMICS

- 1. All members of the Castle View High School golf team are expected to perform in the classroom as well as on the course. Academics are always the number one priority. With this in mind, it is the policy of the Boys' golf team that all players must be passing all classes and receiving acceptable citizenship reviews in order to play on this team. Any player who is failing any class(es) is subject to the following:
 - a. If the player is receiving one (1) failing grade (F), the player will be able to practice but will NOT be permitted to play in any tournaments as long as the player is still receiving a failing grade. THERE ARE NO EXCEPTIONS TO THIS RULE.
 - b. If the player is receiving two (2) or more failing grades, the player is not eligible to practice or play in any of the tournaments until the grades become passing. THERE ARE NO EXCEPTIONS TO THIS RULE.
- 2. Any players who receive "unacceptable" citizenship marks will NOT be able to participate in any tournaments until the mark(s) is/are upgraded to "acceptable." THERE ARE NOT EXCEPTIONS TO THIS RULE.

PERFORMANCE

- 1. I agree to participate in practices and tournaments with a positive attitude. I will listen to instruction and receive any comments from any coaches or fellow players with an open mind.
- 2. I understand and agree that golf is a game, which requires nothing less than 100% honesty and good sportsmanship. Hence, it is MANDATORY that all Castle View High School players treat all opposing players, teammates, coaches, school officials and course employees with the utmost degree of respect. We are representing our school, our community, our teammates, our coaches, and perhaps most importantly, our parents and ourselves. Any golfer who does not adhere to this rule will be disciplined, including the possibility of removal from the team.
- 3. I understand that getting along with ALL of my teammates is required. All conversations with teammates should be positive, as we are all trying to accomplish

- the same goals. I realize that every golfer's ability level is different and that I will try to encourage and promote a positive relationship with all of my teammates.
- 4. I understand that golf is a game which requires a full commitment to practice. I understand that I MUST contact my coach BEFORE PRACTICE if I cannot attend any scheduled practices. I understand that the same is true for any scheduled tournaments. Should I be unable to notify my coach, I understand that I MUST notify the team captain BEFORE practice or a tournament so that he can notify the coaching staff. I also understand that my failure to do this WILL result in a disciplinary warning on the first offense and the loss of playing in the next scheduled tournament on the second offense. A third offense WILL result in suspension from the team and possible dismissal from the team.
- 5. I understand that the coaching staff requires full attention during any team meetings or instructions during practice. I also understand that the coaching staff demands and deserves my full respect, whether or not I personally agree with the coaching staff. The failure to observe these rules WILL result in a warning on the first offense and the loss of playing time on the second or subsequent offense.
- 6. I understand that Castle View High School has a zero tolerance policy for drug abuse, including tobacco and alcohol. I understand that any violation of this rule may result in my immediate suspension and/or dismissal from the team.
- 7. I understand that golf is an honorable sport and that foul or abusive language on the golf course, or damage to the golf course, will NOT be tolerated. I understand that the penalty for foul/abusive language is a disciplinary warning on the first offense and that I will not be able to participate in the next golf tournament on the second violation. A third violation WILL result in suspension from the team, with the possibility of dismissal from the team should the inappropriate behavior not be corrected. Any intentional damage to the golf course or the player's golf clubs will result in an immediate suspension from the team and possible dismissal from the team at the discretion of the head coach.
- 8. I understand that golf courses have rules concerning dress while on the course. For all golf tournaments and practices, I understand that I will NOT be permitted to play if I am wearing jeans, cargo pants or cargo shorts, t-shirts or other inappropriate attire. I understand that it is up to me to make sure that I am dressed appropriately for each golf tournament and practice that I wish to participate in.
- 9. I understand that my playing time is based on the head coach's evaluation of my ability, attitude and effort. I understand that participating at 100% effort and attitude at all times will enhance my chances to play.
